The NBI was also able to share our thinking of economic transition risk that developing countries experience as a result of climate change and the shift to a low carbon economy. Steve then attended the World Business Council for Sustainable Development (WBCSD) Delegate Liaison Meeting in Montreux, Switzerland which took place the week after, 1 to 4 April 2019. Here the WBCSD shared their long-term strategy and work programme with their member companies and global partners (the NBI is the South African partner). It was also an opportunity for the NBI to determine which WBCSD programmes would have most relevance for our own members.
