MINISTER BARBARA CREECY LAUNCHES SOUTH AFRICA PAVILION AT COP27 IN SHARM EL-SHEIKH, EGYPT The Minister of Forestry, Fisheries and the Environment, Her Excellency Barbara Creecy will on Monday, 14 November 2022, launch the South Africa Pavilion at COP27 in Sharm El-Sheikh, Egypt.
