**NEW BUSINESS FUND WILL HELP END POWER CRISIS BY SECURING EXPERTISE** The Resource Mobilisation Fund (RMF), which is underpinned and driven by Business for South Africa (B4SA), has sourced philanthropic and private sector funding to procure and donate technical skills and experience to National Energy Crisis Committee (Necom), which will significantly and expeditiously boost the Energy Action Plan, and increase its momentum. The RMF's focus on capacitating government, we are working closely with several partners, including KPMG and ENS, who have defined the governance framework and drafted the procurement policy; as well as the National Business Initiative (NBI) and Business Unity South Africa (BUSA) to procure, screen, contract, deploy, mentor and support the requisite technical capacity and the requisite administrative support. **News24, 14 March 2023.** 

€15M JUST SA LAUNCHED IN BID TO UNLOCK MPUMALANGA TRANSITION PROJECTS A new €15-million initiative has been launched to provide research and technical support for "catalytic" just transition projects in South Africa's Mpumalanga province, currently the centre of South Africa's coal industry and where 22 GW of coal-fired power capacity is scheduled for retirement before 2035. Just SA project director Navina Sanchez, of German development agency GIZ, said the projects would be implemented in a consortium with six South African partners, including the Mpumalanga Green Cluster Agency, GreenCape, Trade and Industrial Policy Strategies, the National Business Initiative, the Youth Employment Service and WWF. Its Net-Zero Industry Act and Critical Raw Materials Act are part of its Green Deal Industrial Plan. The Commission says global investment in the energy transition is set to triple by 2030 from \$1 trillion last year. Absa Corporate and Investment Banking has assisted in Infinity Power Holding's (IPH's) acquisition of Lekela Power. IPH is a joint venture (JV) between Abu Dhabi-based energy company Masdar and Egypt-based Infinity Group established in 2020. The JV targets solar and wind generation projects, at utility-scale as well as commercial and industrial scale, in Africa. In turn, Lekela has operations in South Africa, Senegal, Egypt and Ghana, and was sold by private equity company Actis and renewable energy company Mainstream Renewable Power. **LOW-CARBON HYDROGEN PRESENTS ATTRACTIVE ALTERNATIVE INVESTMENT OPPORTUNITIES FOR INFRASTRUCTURE INVESTORS** New Research by BCG and EDHECinfra Finds Green Hydrogen Will Be \$6 Trillion to \$12 Trillion Investment Opportunity Over Next Three Decades. "As the world works to stay on track with the Paris Agreement, and governments rebuild infrastructure with an eye towards ensuring carbon-neutrality, the infrastructure investment market will continue to expand," said Wilhelm Schmundt, BCG managing director and partner, and global lead for infrastructure investment. "Hydrogen is turning into a lucrative alternative investment opportunity and a logical extension for funds with a mandate to develop sustainable resources." Boston Consulting Group, 21 March 2023.

MAINSTREAM AND ACTIS CLOSE LEKELA SALE, AFRICA'S BIGGEST RENEWABLES DEAL Mainstream Renewable Power, the global wind and solar company, and Actis, a leading global investor in sustainable infrastructure, have successfully completed the sale of 100% of the Lekela platform to Infinity Power, a joint venture between Egypt's Infinity and UAE's Masdar. The transaction generates net proceeds to Mainstream of approximately US\$90 million, subject to certain closing adjustments, with the transaction valued at an enterprise value of approximately US\$1.5 billion. Lekela was established in 2015 as part of a joint venture between Actis (60%), and a Mainstream-led consortium called Mainstream Renewable Power Africa Holdings (MRPAH) (40%), to deliver clean, reliable energy across Africa. Lekela has since become the Africa's largest pure-play renewable energy IPP, with over 1 GW of fully operational wind assets, including five operational wind farms in South Africa (624MW), one

operational wind farm in Egypt (252MW), one operational wind farm in Senegal (159MW) as well as development opportunities in Ghana, Senegal and Egypt. Mainstream Renewable Power, 20 March 2023.

**CROSS-BORDER TEAM ADVISES INFINITY POWER ON LEKELA POWER ACQUISITION** Global law firm Norton Rose Fulbright advised Infinity Power in connection with its acquisition of the entire shareholding of Lekela Power (Lekela), an Africa based wind power platform, from a consortium led by Actis and Mainstream funds. Lekela currently operates 1 gigawatt (GW) of wind power projects in South Africa, Egypt and Senegal, and has a 1.8 GW project pipeline, which are in various stages of development. This acquisition makes Infinity Power Africa's largest pure play renewable power company. **Norton Rose Fulbright, 20 March 2023.**

**PEPSICO BEVERAGES & FRITO-LAY ANNOUNCE \$3.3 MILLION IN WATER REPLENISHMENT PROJECTS TO DRIVE PROGRESS TOWARD PEPSICO POSITIVE WATER POSITIVE GOALS** PepsiCo Beverages North America (PBNA) and Frito-Lay North America (FLNA) announced a commitment of \$3.3 million in funds toward water replenishment projects across North America. These projects aim to advance PepsiCo's ambitious effort to become Net Water Positive by 2030, which includes reducing absolute water use and replenishing back into the local watershed more than 100% of the water used at company-owned and third-party sites in high water-risk areas. **PepsiCo, 14 March 2023.** 

WESSA SCHOOLS PROGRAMME AWARDS IN PARTNERSHIP WITH SUN INTERNATIONAL Sun International's two-year partnership with the Wildlife and Environment Society of South Africa (WESSA) to create eco-classrooms and build environmental resilience in schools and their communities has seen Gauteng schools win awards. Since the partnership started last year, eight schools in Gauteng have now completed health and safety workshops and been awarded bronze certificates, which are awarded to schools in their first year of the WESSA Eco-Schools programmes. To achieve bronze status, schools need to implement one project under one of the eco-school themes. The Sun International schools are taking part in a health and well-being project, focusing on environmental and social issues that impact health and safety, such as pollution, substance abuse, crime or gender-based violence. **OP-ED BY ESKOM BOARD CHAIRPERSON, MPHO MAKWANA: ESKOM IS PROACTIVELY DEALING WITH FRAUD AND CORRUPTION** Eskom is rooting out fraud and corruption within its ranks and supply chain through proactively implementing recommendations made by the Zondo Commission and beyond. They are redressing the effects of State Capture and to this effect, established the State Capture Task Team (SCTT) on 14 July 2022. The organisation reaffirmed its cooperation with the National Prosecuting Authority (NPA) in May last year to ensure the most effective coordinated responses to Sate Capture cases and other serious crimes related to Eskom's operations. A public declaration of this commitment was made by Eskom and the NPA in a joint media statement on 5 May 2022. The State Owned Enterprise (SEO)is also working closely with the Special Investigative Unit (SIU) and are providing regular progress updates to the Standing Committee on Public Accounts (SCOPA), with the most recent update jointly presented to SCOPA on 24 January 2023. **Eskom, 10 March 2023.**

**SIGNIFICANT FUNDING REQUIRED TO POSITIVELY UNDERTAKE JUST ENERGY TRANSITION** – **REPORT** The second of three reports looking into South Africa's energy transition, released by the African Climate Foundation (ACF) this week, finds that significant amounts of funding will be required to promote positive social outcomes and to prevent a deterioration in poverty and unemployment that a completely unmanaged transition would bring about. **Engineering News, 23 March 2023.** 

ROAD FREIGHT ZERO: TOWARDS A HOLISTIC REGULATORY FRAMEWORK FOR REDUCING ROAD FREIGHT EMISSIONS IN EUROPE As a response to the European Commission's recently proposed revision of the CO<sub>2</sub> standards for trucks, trailers and

buses, this briefing paper identifies eight policy enablers considered necessary to achieving more ambitious CO<sub>2</sub> reduction targets for trucks. The paper purports that a more holistic regulatory framework will create the enabling conditions to support the roll-out of zero-emission fleets and infrastructure across the European Union, on par with the commitments made by value-chain actors. **SOLAR UNDERPINS RECORD RENEWABLES ADDITIONS IN 2022** A record 295 GW of new renewable-energy capacity was added globally in 2022, with the 9.6% year-on-year growth underpinned largely by record growth in solar photovoltaic (PV) installations, which accounted for almost two-thirds of all new renewables additions with 192 GW installed. The International Renewable Energy Agency's (Irena's) 'Renewable Capacity Statistics 2023' report shows that with installations of 75 GW wind power came in as the second most deployed renewables technology in 2022, but at a pace that had slowed materially from the 111 GW of wind added in 2020. **Engineering News, 22 March 2023.**

**FLAGSHIP UN REPORT EXTOLLS WIN-WIN WATER PARTNERSHIPS TO AVERT GLOBAL CRISIS** Water starts wars, puts out fires, and is key to human survival, but ensuring access for all hinges largely on improving cooperation, according to a new flagship UN report. Launched ahead of the UN 2023 Water Conference, the new edition of the UN World Water Development Report focuses on twin themes of partnerships and cooperation. Published by the UN Education, Scientific and Cultural Organization (UNESCO), the report highlights collaborative ways actors can work together to overcome common challenges. **United Nations, 21 March 2023.** 

SCALING LOW-CARBON DESIGN AND CONSTRUCTION WITH CONCRETE: ENABLING THE PATH TO NET-ZERO FOR BUILDINGS AND INFRASTRUCTURE Buildings and infrastructure are responsible for approximately 40% of global carbon emissions each year, around 15 Gigatons. Unabated, this number could grow dramatically, effectively undercutting decarbonization efforts in other sectors. A substantial share of these emissions is released before an asset is ever used. The production of building materials accounts for an estimated 15-20% of buildings emissions and 50-60% of infrastructure emissions. Among building materials, cement is particularly important, accounting for around 30% of building materials emissions and 7% of global carbon emissions. Therefore, in order to reduce the carbon footprint of buildings and infrastructure, it is critical to examine the manufacturing and use of concrete, and decarbonizing the industry is crucial to achieving net-zero.
