**CARBON NEUTRAL AND NET ZERO – WHAT DO THEY MEAN?** Both carbon neutral and net zero refer to different actions that are essential to combat climate change. Carbon neutral can cover a defined part of business operations and typically accounts for CO<sub>2</sub> emissions, but not other greenhouse gases.
