AFRICAN HEADS OF STATES BACK AFCFTA REPORT African heads of state and global CEOs have backed the launch of the first-of-its-kind report on how public-private partnerships can support the implementation of the African Continental Free Trade Area (AfCFTA). At the World Economic Forum (WEF) Annual Meetings on 18 January 2023, the leaders endorsed the "AfCFTA: A New Era for Global Business and Investment in Africa" report, which highlights the high potential for companies investing in the world's largest free trade area IOL, 19 January 2023.

**SECRETARY FOR ENVIRONMENT AND ECOLOGY OF HONG KONG, CHINA AND GOVERNING MAYOR OF OSLO JOIN C40 STEERING COMMITTEE** Tse Chin-wan, Secretary for Environment and Ecology of Hong Kong, China, and Raymond Johansen, Governing Mayor of Oslo, Norway, have been elected Vice Chairs of the C40 Steering Committee, the governing body providing strategic direction for the global network of nearly 100 cities committed to addressing the climate crisis. **C40 Cities, 16 January 2023**.

UN CHIEF CALLS FOR RENEWABLE ENERGY 'REVOLUTION' FOR A BRIGHTER GLOBAL FUTURE Renewable energy is the only credible path forward if the world is to avert a climate catastrophe, UN Secretary-General António Guterres said on Saturday, outlining a five-point plan for a just transition. "Only renewables can safeguard our future, close the energy access gap, stabilize prices and ensure energy security," he said in a video message to the 13th Session of the International Renewable Energy Agency (IRENA) Assembly. "Together, let's jumpstart a renewables revolution and create a brighter future for all." United Nations, 14 January 2023.

ANGLO AMERICAN LOADS FIRST LNG DUAL-FUELED VESSEL IN CHARTERED FLEET, CUTTING EMISSIONS BY UP TO 35% Anglo American announces that its newly launched LNG dual-fueled Capesize+ vessel, the Ubuntu Harmony, has loaded its first cargo of iron ore from its Kumba operations in South Africa. The vessel is the first of ten LNG dual-fueled new-build ships that Anglo American will introduce to its chartered fleet during the course of 2023 and 2024, delivering an estimated 35% reduction in CO2 emissions compared to ships fueled by conventional marine oil fuel. The use of LNG will also lead to a significant reduction of nitrogen oxides and particulate matter from vessel exhausts, while new technology also eliminates the release of unburnt methane. AIR LIQUIDE AND SASOL SIGN FIRST LONG-TERM CONTRACTS FOR SUPPLY OF RENEWABLE ENERGY TO THE SECUNDA SITE Air Liquide and Sasol have signed two Power Purchase Agreements (PPA) with Enel Green Power for the long-term supply of a total capacity of 220 MW of renewable power to Sasol's Secunda site, in South Africa, where Air Liquide operates the biggest oxygen production site in the world. These PPAs are the first results of the Request for Proposal (RFP) process launched jointly by Air Liquide and Sasol in April, 2021, for the procurement of a total capacity of 900 MW of renewable energy. They will significantly contribute to the decarbonization of the Secunda site, and in particular to the targeted reduction of 30 % to 40 % of the CO2 emissions associated with oxygen production by 2031. FIRST COHORT OF 9 INNOVATIVE LOW-CARBON PROJECTS LAUNCHED IN EGYPT The Climate Finance Accelerator (CFA) Egypt, funded by the UK Government, has chosen nine innovative low-carbon climate projects from across Egypt to make up its first cohort to receive technical and financial support to help them attract the investment they need. Genesis Analytics, in partnership with Acumen Consulting Egypt, has been working with PwC to develop a sustainable pipeline of bankable, low-carbon projects in Egypt and identify suitable financing for them. BCG LAUNCHES SUPPLY CHAIN NET ZERO ACADEMY TO UPSKILL SUPPLIERS AND PROCUREMENT TEAMS To address skills and training gaps and accelerate scope 3 decarbonization, Boston Consulting Group (BCG) is launching the Supply Chain Net Zero Academy. The Academy's modular curriculum offers a combination of interactive self-led courses and expert-led launchpad classes, to upskill both suppliers and internal procurement teams on topics from climate fundamentals to deep decarbonization levers, all powered by BCG U's best-in-class learning platform. **ERM ADVISES PLENITUDE ON AGREEMENT TO ACQUIRE RENEWABLE ENERGY GROUP PLT** ERM, the world's largest pure play sustainability consultancy, has advised Plenitude, an Eni controlled company integrating the production of renewables, the sale of energy services and a large network of electric vehicle charging points, on its agreement to acquire PLT, an integrated Italian group that produces electricity from renewables and supplies energy to 90,000 retail customers. **ERM, 12 January 2023.** 

MONDI'S SCIENCE-BASED NET-ZERO TARGETS FOR GREENHOUSE GAS EMISSIONS REDUCTION VALIDATED BY SBTI Mondi, a leading global packaging and paper solutions provider, confirms that the Science Based Targets initiative (SBTi) has assessed and approved its science-based Net-Zero targets. The targets covering greenhouse gas (GHG) emissions from Mondi's operations and supply chain (Scopes 1, 2 and 3) are consistent with a reduction required to keep global warming to 1.5°C, needed to prevent the most damaging effects of climate change according to the latest climate science. Mondi announced its commitment to Net-Zero GHG emissions reduction in January 2022 and is among the first companies in the packaging and paper sector to have validated Net-Zero targets from the SBTi. **IFC INVESTS IN GROWTHPOINT PROPERTIES' GREEN BOND** To promote more sustainable and resource efficient buildings in South Africa, IFC announced on 14 December 2022, an investment in a green bond issued by Growthpoint Properties Limited that will help the company finance energy and water efficiency improvements in its existing commercial properties. **Growthpoint, 14 December 2022.** 

OLD MUTUAL PARTNERS WITH NEDBANK AND STANDARD BANK ON SUSTAINABILITY-LINKED FUNDING FACILITIES SET TO DRIVE ESG CHANGE. South African financial services giant, Old Mutual, has partnered with Nedbank and Standard Bank on

the refinance of Old Mutuals revolving loan facilities. The refinanced facilities are sustainable finance facilities which are set to drive ESG and sustainable growth outcomes. Casper Troskie, Chief Financial Officer at Old Mutual Limited said: "We recognise the interconnectivity between the economic, social and environmental systems we operate in, and the urgency to transform our collective growth path to one that is more socially inclusive, low carbon and resource efficient. Collaborating in this way practically enables us to transform the financial services sector to meet the changing needs of our people and planet." Old Mutual, 13 December 2022.

MAINSTREAM CONSORTIUM SIGNS AGREEMENTS FOR SOUTH AFRICA SOLAR PROJECTS Mainstream Renewable Power, the global pure-play renewable energy company, and its Ikamva Consortium have signed project agreements for six solar plants, with a combined capacity of 450 MW, awarded under Round 5 of South Africa's Renewable Energy Independent Power Producer Procurement Programme (REIPPPP). Mainstream Renewables, 8 December 2022.

FIRST CONCENTRATED SOLAR THERMAL POWER PLANT WITH MOLTEN SALT CENTRAL RECEIVER Grinaker-LTA's role in the Redstone Concentrated Solar Thermal (CSP) power plant project in the Northern Cape, which is the largest investment made to date in terms of the South African Renewable Energy Independent Power Producer (REIPP) Procurement Programme, consists of the construction of package C3 civils permanent works. This has afforded Grinaker-LTA the opportunity to gain a firm foothold in the growing local renewable energy space. EMISSIONS TRANSPARENCY: PATHFINDER FRAMEWORK PROVIDES UPDATED GUIDANCE FOR THE ACCOUNTING AND EXCHANGE OF PRODUCT LIFE CYCLE EMISSIONS The Partnership for Carbon Transparency (PACT), powered by the World Business Council for Sustainable Development (WBCSD), is launching version 2.0 of "Pathfinder Framework: Guidance for the Accounting and Exchange of Product Life Cycle Emissions". Originally launched at COP26 in Glasgow, the Pathfinder Framework builds on the longstanding work with the World Resources Institute under the GHG Protocol to take a cross-sectoral approach to help organizations develop and exchange primary-data-based product carbon footprints (PCFs) across the value chain. HOW STAKEHOLDER METRICS REPORTING CAN DRIVE SUSTAINABLE BUSINESS: A CASE FOR EL SALVADOR, GUATEMALA AND HONDURAS Being a sustainable business is now essential to being a successful business. Comparable sustainability information is increasingly important for stakeholder decision-making, so companies in Central America, as elsewhere, need to progress their sustainability measurements and reporting and use internationally aligned standards and metrics to remain part of or join multinational supply chains, attract investment, and stay competitive.
