She is a member of the Presidential Climate Commission (PCC) Commissioners' Climate Finance Advisory Group, the BRICS Financial Sector Working Group, a non-executive director of the WWF South Africa, and of the Green Building Council of South Africa (GBCSA). She is the winner of the SERAS Africa CSR/Sustainability Professional 2021 and the IRMSA ESG Sustainability Professional 2020 awards.

The Chairperson of the NBI Board, Cas Coovadia, emphasised Shameela's key qualities that led to her being selected as the NBI's new CEO: "Shameela is an indomitable leader, who is ready and committed to lead the NBI in this exciting new chapter in her career. Her combination of integrated strategy and sustainability knowledge, track record of delivery on notable local and global projects, extensive business experience through her various leadership roles, as well as crucial insights and understandings of the NBI's key work areas, make her the ideal choice for the role."

As a coalition of close to a hundred South African and multi-national member companies, the NBI effects change in the key cross-cutting and multi-dimensional areas of Economic Inclusion, Social Transformation, Environmental Sustainability and Institutional Capacity Building. Shameela's network and prior experience is a fabulous launch pad for taking these initiatives to the next level. In addition to her many accolades, she is also a member of the Institute of Directors of Southern Africa, has served on the Integrated Reporting Committee of SA Working Group, the Code for Responsible Investing South Africa committee, the Sustainable Stock Exchanges Initiative's member group, and the African Securities Exchanges Association sustainability group, amongst others. Shameela is furthermore strategically positioned to build the NBI's presence with international organisations through her business networks. She is a respected speaker at local and global events and a regular contributor to media articles. This will be a crucial value-add to NBI's local and international partners, members and stakeholders in the environmental sustainability and socio-economic development space.
