This is part of the company's pep+ (PepsiCo Positive) agenda – a strategic end-to-end transformation with sustainability at the center of how it will create growth and value by inspiring positive change for the planet and people. BUILDING SUSTAINABLE LOGISTICS TO CUT CARBON: SUPPLY CHAIN'S ROLE IN CLIMATE ACTION Following a difficult and tumultuous few years for the warehousing and logistics industry, there is hope on the horizon. Global supply chain pressures have gradually begun to ease, prompting many to adopt an optimistic outlook on the progress of the sector as it navigates its post-pandemic response. However, due to the enormous impact of the global supply chain on carbon emissions, sustainability progress still hangs in the balance as it becomes apparent that the UN Paris Agreement climate pledge is at real risk of being missed unless action is taken immediately. According to a report by the National Business Initiative in partnership with Business Unity South Africa and Boston Consulting Group, South Africa's transport sector is the third largest emitting sector, with over 90% of these emissions coming from road transport. TRACIT RECOMMENDS GOVT ESTABLISH AN INTERAGENCY ANTI-ILLICIT TRADE COORDINATOR Global independent private organisation the Transnational Alliance to Combat Illicit Trade (Tracit) has published a report on illicit trade activity in South Africa, with recommendations on how the country can increase its efforts to curb the problem. For South Africa to achieve its critical development objectives, it must effectively tackle what is a pervasive and complex problem of illicit trade that undermines and corrodes the entire economy, Business Unity South Africa (Busa) states, in hosting the launch of the report on behalf of Tracit. AT \$1BN A DAY, SOLAR INVESTMENT TO OUTPACE OIL FOR FIRST TIME IN 2023 The International Energy Agency (IEA) is forecasting that investment in solar will rise to more than \$1 billion a day, or to some \$380 billion for 2023 as a whole, increasing spending on the renewable technology to above upstream oil for the first time ever. The agency's World Energy Investment also indicates that more than \$1.7-trillion of the \$2.8 trillion to be invested in energy globally this year, will be

directed towards clean technologies, including renewables, electric vehicles, nuclear, grids, storage, low-emission fuels, efficiency improvements and heat pumps. **Engineering News, 25 May 2023.**

AFRICAN FREE TRADE AREA COULD SPUR SUSTAINABLE GROWTH: UN CHIEF Mr. Guterres was speaking on the final day of the annual Africa Dialogue Series in New York, where the focus this year was on accelerating implementation of the African Continental Free Trade Area (AfCFTA) – set to be the largest in the world. He said the AfCFTA is set to be an engine of that growth. "Its full implementation could generate income gains of up to nine per cent by 2035, according to latest estimates. This would lift up to 50 million people out of extreme poverty and reduce income inequalities," he added. The Secretary-General stressed that realizing the AfCFTA promise calls for action across four critical areas, starting with boosting access to financial resources and investment. "We need a fundamental reform of the global financial system so that Africa is represented at the highest level," he said. Barriers that hold back intra-African trade and production capacities must also be broken down, including through eliminating tariffs, building "made in Africa" supply chains, and harmonizing regulations that would enable investment. GREEN LIGHT FOR GLOBAL GREENHOUSE GAS TRACKING NETWORK A hundred and ninety-three countries have unanimously approved the creation of a global greenhouse gas monitoring mechanism, the World Meteorological Organization (WMO) announced. The landmark decision comes as heat-trapping greenhouse gas concentrations are at record levels – "higher than at any time over the last 800,000 years", WMO warned. The new Global Greenhouse Gas Watch will combine observations from Earth and from space with modelling, to fill critical information gaps. It will build on WMO's experience in coordinating international collaboration on weather prediction. The agency said that the exchange of data will be "free and unrestricted", in support of the Paris Agreement on climate change. **United Nations, 24 May 2023.**

This year's global celebrations are particularly significant and bring a renewed sense of hope as they coincide with the adoption of the Kunming-Montreal Global Biodiversity Framework (GBF) at COP 15 in Montreal. MAINSTREAM RENEWABLE POWER, REVENTUS POWER, AGL, AND DIRECT INFRASTRUCTURE SUBMIT APPLICATION FOR 2.5 GW OFFSHORE WIND DEVELOPMENT IN GIPPSLAND, AUSTRALIA A consortium of Australian and global companies, comprising Mainstream Renewable Power ("Mainstream"), Reventus Power, AGL and DIRECT Infrastructure has submitted a feasibility license application for a 2.5 GW offshore wind development off the coast of Victoria, Australia. The consortium brings significant global offshore wind development track records, coupled with deep Australian industry and energy generation knowledge to deliver on the nation's offshore wind ambitions. The area in the Bass Strait off Gippsland, Victoria, was the first offshore wind zone to be declared by the Australian Government. According to the Australian Department of

Climate Change, Energy, the Environment and Water, the 15,000 km2 zone has the potential to support more than 10 GW of year-round energy generation and the creation of thousands of new jobs. Mainstream Renewable, 30 May 2023.
