GLOBAL CITY LEADERS OFFER SOLUTIONS TO G20 AHEAD OF HEADS OF STATE MEETING ON CLIMATE, ECONOMIC AND HUMANITARIAN CRISES More than 430 global and city leaders gathered in Ahmedabad this week at the 6th Urban 20 Summit, ahead of G20 meetings later this year in India.

A record number of 105 cities have endorsed this year's U20 Communiqué, which calls on national and city leaders to work together as "valuable and equal partners" to halve global emissions by 2030 and address inequalities, while creating safe, resilient and just societies and promoting equitable, affordable and inclusive development. U20 members highlight the urgent need to overhaul development finance to increase support for climate action in cities, especially for adaptation in Global South cities facing the brunt of the climate crisis and stress the key role local public service provision plays in sustainable development as a key instrument for delivering social security and protections. **C40 Cities, 8 July 2023.**

EXXARO'S CENNERGI: EMPOWERING COMMUNITIES THROUGH TRANSFORMATIVE EDUCATIONAL INITIATIVES Exxaro Resources, through its wholly owned subsidiary and renewable energy solutions business, Cennergi, is empowering communities through a range of impactful educational initiatives. Through strategic partnerships, funding programmes, and training initiatives, the Company is creating a brighter future for young learners to foster socio-economic development in the regions it operates. Cennergi launched its Early Childhood Development (ECD) Programme, in 2021 in collaboration with Early Inspiration, a specialised organisation in early childhood development. DELOITTE REACHES CRITICAL MILESTONE IN ITS TRANSFORMATION JOURNEY Deloitte South Africa has reached a critical milestone in its transformation journey when, in June this year, the firm achieved 51% Black representation at partnership level. As far back as 1970's, Deloitte's inclusive ethos saw the firm deliberately recruiting and developing Black accountants who could eventually become partners. In the 1970's Deloitte set up a school in Soweto to help prepare matriculants to study bookkeeping and accounting at university. **Deloitte, 12 July 2023.**

CLIMATE-SMART AGRICULTURE, NATURE-BASED SOLUTIONS, AND AGROECOLOGY Including the agricultural sector in climate change actions and policy has become increasingly more important over the past decade. Agriculture was first brought into international climate discussions at the 17th Conference of the Parties — COP of the United National Framework Convention on Climate Change (UNFCCC) which was held in Durban, South Africa in 2011. Since then, several concepts have been used to integrate agriculture into climate change actions for both mitigation and adaptation. These include climate-smart agriculture, nature-based solutions, and agroecology. But what are the main differences between these concepts (are they just buzzwords?), and how do they translate into farm-level practices? Climate Neutral Group, 7 July 2023.

FY23 achievements include contributing to the installation of over 160 gigawatts of renewable energy capacity (equivalent to the annual carbon emissions of 36 million+ US households), remediating 279 hectares of land for beneficial use increasing project sales aligned to helping clients transition to a lower-carbon economy by 34% on the previous year and helping to develop the Business Commission to Tackle Inequality's (BCTI) flagship report. UNIPER AND SASOL ECOFT CONTINUE TO DEVELOP SKYFUELH2 Uniper and Sasol ecoFT have jointly applied for funding from the Swedish Energy Agency for the next phase of development and to the EU Innovation Fund for overall project funding. The final decision on the award is likely to be received during the next study phase. In SkyFuelH2, biomass and renewable hydrogen feedstock will be combined using Sasol's proprietary Fischer-Tropsch technology to produce SAF on an industrial scale, which will be a global first. The biomass comes from processed forestry residues. The hydrogen will come from an electrolysis unit that uses locally available renewable electricity. Both ensure a fully sustainable value chain and a product in accordance with the Renewable Energy Directive (RED II/III). The partners will continue further development work, with the support of the Sollefteå municipality. The ambition is to begin construction of the SkyFuelH2 facility in 2025, subject to achieving FID (final investment decision), and potentially supplying the aviation industry with sustainable aviation fuel as early as 2028. REPORT LAUNCH EVENT SETS STAGE FOR HLPF'S REVIEW OF SDG 7 A high-level special event launched the 2023 editions of the Energy Progress Report and the SDG 7 Policy Briefs, to support governments' in-depth review of SDG 7 (affordable and clean energy) at this year's UN High-level Political Forum on Sustainable Development (HLPF). Many speakers stressed that scaled up action, including financing, will be essential if SDG 7 is to be achieved by 2030. **SDG Knowledge Hub, 12 July 2023.**

ENERGY: THESE 8 COUNTRIES HAVE SCALED UP RENEWABLE ENERGY THE FASTEST Renewable energy has grown exponentially over the past two decades thanks to government policy and falling prices, far faster than many experts expected. The report will support in-depth review of SDG 6 (clean water and sanitation) at the July session of the UN High-level Political Forum on Sustainable Development (HLPF) and high-level review of progress on the 2030 Agenda for Sustainable Development at the SDG Summit in September. CLIMATE: 5 COUNTRIES TAKING ACTION TO REACH NET-ZERO TARGETS To date, over 90 countries have set net-zero emissions targets, committing to help prevent the most harmful impacts from climate change. But questions remain around the credibility of many of these pledges and whether these goals will be met. Together, countries with net-zero

targets — which include China, the United States and India — are responsible for nearly 80% of global greenhouse emissions. Thousands more regions, cities and companies have also set net-zero targets of their own. GENDER: ENABLING WOMEN AS KEY ACTORS IN NATURE-BASED SOLUTIONS This paper aims to better understand the role of rural women in Nature-based Solutions (NbS) and to provide insights on how to support them. The gender dimension remains underexplored in the literature on NbS. Most studies focus on the biophysical and technical aspects of NbS and their global and transboundary scales of impact. The studies that do investigate the social aspects, such as opportunity costs and poverty impacts, tend to treat households as a congruent unit, bypassing intrahousehold and gender dynamics. Research shows that the success of NbS hinges on the inclusion of critical stakeholders, including women. **World Resources Institute, 5 July 2023.**

59TH SESSION OF THE IPCC (IPCC 59) | **25-28 July 2023**| The 59th session of the Intergovernmental Panel on Climate Change (IPCC 59) will convene from 25-28 July 2023. The meeting will be the first meeting of the seventh assessment cycle. The IPCC was established in 1988 by the World Meteorological Organization (WMO) and the UN Environment Programme (UNEP) to "assess, in a comprehensive, objective, open, and transparent manner, the scientific, technical, and socio-economic information relevant to understanding human-induced climate change, its potential impacts, and

adaptation and mitigation options." The IPCC does not undertake new research or monitor climate-related data. Instead, it conducts assessments of the state of climate change knowledge based on published, peer reviewed scientific and technical literature. The Panel's reports are intended to be policy relevant but not policy prescriptive. They provide key inputs into international climate change negotiations. | Website & further details.

38TH UN-WATER MEETING | **18-19 August 2023** | The 38th UN-Water Meeting will convene in August 2023 under the theme, 'Seeds of Change: Innovative Solutions for a Water-wise World'.
