GAPS IN THE CLIMATE FINANCE INVESTMENT CHAIN The Climate Finance Accelerator's (CFA) updated report looks at each of the four stages of the project cycle - initiation, development, primary funding and secondary funding/ refinancing - and examines where the gaps lie for project developers looking to access different types of potential investors. The report analyses the projects that have applied to the CFA, including their sectors, their state of readiness for investment and the amount of investment they sought. Finally, it provides some specific recommendations for governments, grant providers, angel investors/ venture capital, private equity/ impact funds, corporate funders, projects developers/

entrepreneurs and later stage investors. The CFA team believes the implementation of these recommendations would help to close some of the gaps identified in the climate finance investment chain. Access the report **here.**

DRAFT FOR COMMENT: CODE FOR ETHICAL LEADERSHIP IN LOCAL GOVERNMENT This Code for Ethical Leadership in Local Government was developed as part of the Local Government Ethical Leadership Initiative — a partnership between The Ethics Institute, the Department for Cooperative Governance, the South African Local Government Association, and the Moral Regeneration Movement. It is more than two years in the making, following on country-wide research and consultation. Focus groups and interviews were conducted in all of South Africa's provinces to ascertain the challenges around ethical leadership in local government, followed by a national survey. Subsequent to this a draft version of the Code was taken back for consultation in each of the provinces. This exposure draft brings together all comments to date and is the final opportunity for comments prior to the formal launch. Moreover, fewer than one per cent of women and girls globally live in a country with both high women's empowerment and a small gender gap in areas such as health and education. Meanwhile, 3.1 billion women and girls - more than 90 per cent of the world's female population - live in countries characterized by a large women's empowerment deficit and a large gender gap. LOCAL GOVERNMENT: LIMPOPO WATER PROJECT SERVES AS PPP MODEL FOR MUNICIPALITIES A multi-year public-private partnership (PPP) to upgrade the Masodi wastewater treatment works (WWTW), in Limpopo, serves as a model for other municipalities to embrace partnerships and collaborations with the private sector for socioeconomic development of their communities. 59TH SESSION OF THE IPCC (IPCC 59) | **25-28 July 2023**| The 59th session of the Intergovernmental Panel on Climate Change (IPCC 59) will convene from 25-28 July 2023. The meeting will be the first meeting of the seventh assessment cycle. The IPCC was established in 1988 by the World Meteorological Organization (WMO) and the UN Environment Programme (UNEP) to "assess, in a comprehensive, objective, open, and transparent manner, the scientific, technical, and socioeconomic information relevant to understanding human-induced climate change, its potential impacts, and adaptation and mitigation options." The IPCC does not undertake new research or monitor climate-related data. Instead, it conducts assessments of the state of climate change knowledge based on published, peer reviewed scientific and technical literature. The Panel's reports are intended to be policy relevant but not policy prescriptive. They provide key inputs into international climate change negotiations. | Website & further details.
