# How the NBI is addressing the Intergenerational Effects of Corruption

The NBI's Intergenerational Leadership Dialogues serve to activate Bold and Transformative Leadership by providing a platform for the youth to engage in constructive dialogue, critical engagement, and input on issues of public concern and implementing social transformation across generations. The focus of these dialogues is to amplify the voices of young people. A critical element of this work is to enable the youth to share their concerns and frustrations, which stem from ongoing economic inequalities, corrupt leadership, and a lack of social integration.

### The Effects of Corruption on the Youth

Youth in South Africa are disproportionately affected by corruption and are already largely excluded from decision-making processes. Corruption deepens the power gap between those in powerful positions and those affected by these decisions, both in the public and private sectors. The current load-shedding crisis, youth unemployment, economic downturn, climate change, and the gross inequality faced by the youth in South Africa – are a product of corruption, and unethical leadership by those in power. According to the UN Global Resource for Anti-Corruption Education and Youth Empowerment [1], "...engaging youth is key to tackling the challenges that corruption poses to society. To meaningfully engage youth, young people not only need to be involved, but the capacity and "voice" of the youth needs to be strengthened." It is essential that we not only

engage the youth on issues around anti-corruption, but also create an avenue for education on ethical leadership and the importance of ethical awareness, as they become participants and contributors to society and the workplace.

#### The Role of Youth in Ethical Leadership and Anti-Corruption

Youth participation in leadership is an important pillar of a thriving society, but many youth share the viewpoint that professional and government spaces do not allow them to engage safely without fear of retribution. They see leadership as being oppressive rather than empowering, exclusionary rather than welcoming, and divorced from their everyday realities and struggles. With corruption at the forefront of every dialogue around economic inclusion, state accountability, and collaboration, it gives the impression that in order to be a part of the group that benefits, one must engage in unethical practices. These assumptions are fueled by the worsening unemployment crisis and recurring reports of money being exchanged for lucrative projects, access to higher education and secure jobs. However, this is not an isolated problem, it feeds into the increasing number of people turning to crime to survive.

# How the NBI is Contributing Towards Ethical Leadership and Accountability

Corruption not only hinders social progress and stifles economic growth, but it also contributes greatly to lawlessness and hinders the ability of the state to serve and protect its citizens.

This requires understanding the nuances of organisational culture in order to strengthen the ethical awareness of employees when faced with complex issues. One of the ways we do this is by supporting culture change within the private and public sectors by building capacity through Ethical Leadership and Anti-Corruption (ELAC) training.
