PRIDE SIGNIFICANCE, THE PINK ECONOMY, AND THE PRIVATE SECTOR: THE ROLE OF THE PRIVATE SECTOR IN ENSURING THE SOCIAL AND ECONOMIC PARTICIPATION OF THE LGBTQIA+ COMMUNITY IN SOUTH AFRICA (QUICK BRIEF) Pride Month in South Africa commemorates a milestone moment in African history- where the first pride march on the African continent took place in Johannesburg, South Africa on 13 October 1990. It occurred during the apartheid regime- a period where it was illegal to be lesbian or gay in South Africa. Resultantly, the first pride march was used as a political advocacy protesting platform to emphasise the legal discrimination against the LGBT group. those who self-identify as LGBTQIA+ are particularly vulnerable to common forms of discrimination relative to cisgender and heterosexual individuals due to their gender identity, gender expression and sexual orientation. These include barriers to employment; realisation of certain rights; access to services; mistreatment; judgement and bullying as well as emotional, psychological, and physical abuse. Companies need to continuously engage with the nuances of belonging in the workplace, as this has a direct correlation to an organisation's ability to attract and retain talent, extend support, and foster an environment which recognises that diversity and equity are inextricably connected to the bottom-line. **CLIMATE CHANGE EMBROIDERED ARTWORK, CRAFTED BY 43 ARTISTS, UNVEILED IN CAPE TOWN** Ahead of the next global climate meeting, COP28, in Dubai next month, an intricate piece of artwork has been unveiled in Cape Town to highlight the existential threat that climate change poses to human life – particularly for rural people. Of late, the debate has been particularly frenzied. In early October the International Energy Agency released a sobering report. **WOMEN ARE LEADING THE FIGHT TO STOP CLIMATE CHANGE** Over the past few years, international climate policy has been shaped largely by a close-knit group of politicians in the twilight of their careers. Now leaders from beyond the traditional US-Europe-China powercenter—some new to the international stage, others already veterans—are emerging. And women are at the forefront. "Women are now the decision makers that can increase the likelihood of impactful decisions that actually stick," says Jennifer Morgan, Germany's special climate envoy. **Engineering News, 16 November 2023.** 

HALFWAY TOWARDS 2030 CLIMATE TARGETS, WHAT TO EXPECT FROM COP28 sees the first five-yearly Global Stocktake, conducted by the UN Framework Convention on Climate Change. The Global Stocktake urges more action on all fronts, noting that the world is not on track to meet the Paris Agreement's long-term goals. The Global Stocktake gives us a better sense of the gap between what we should be doing and what we are managing to achieve. World Economic Forum, 13 November 2023.

**SOUTH AFRICAN UNIONS TO LAUNCH JUST TRANSITION LABOUR RESEARCH CENTRE** Four South African trade union federations have come together to launch a just transition research centre to develop the technical expertise to help the labour movement in addressing the potential risks posed to workers as a result of the restructuring that will accompany the transition to greater climate resiliency. The centre will initially be housed at Trade and Industrial Policy Strategies (TIPS) and will be supported by the Congress of South African Trade Unions, the Federation of Unions of South Africa, the National Council of Trade Unions and the South African Federation of Trade Unions. **Engineering News, 10 November 2023.** 

**CORRUPTION THREATENS DEMOCRACY ITSELF, RAMAPHOSA SAYS** President Cyril Ramaphosa has said the "rampant and unbridled corruption" that has gutted the South African economy over the past few decades is not just a threat to the economy, but also to the very concept of democracy in South Africa. "If corruption is not arrested or stopped, the greatest damage will not be in the funds that are stolen . . . or the jobs that are lost, it will be in the damaging of our democracy. It will be in making our people have less confidence and have less trust in our democracy," Ramaphosa told delegates at the National Anti-Corruption Advisory Council's (NACAC's) National Anti-Corruption Dialogue, in Johannesburg, on November 8. He commended the efforts of the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State, better known as the Zondo Commission or the State Capture Commission, saying that the State capture enquiry was a watershed moment in South African history. The President further committed to adequately resourcing the NACAC going forward. **Engineering News, 8 November 2023.** 

CLIMATE COMMISSION NAMES WINNERS OF GREEN SOLUTIONS PITCH CHALLENGE The Presidential Climate Commission (PCC), the British High Commission to South Africa and other organisations have crowned Samanjalo and Green Guru as the winners of the first Green Solutions Pitch Challenge focused on Mpumalanga. The other organisations on the judging panel included development programme Grindstone; tech financer Untapped Global; diversified miner Anglo American support programme the Anglo American Foundation; and mining company Seriti Resources' renewable energy arm Seriti Green. The winners were chosen during a pitch event hosted in Emalahleni on November 1. The Green Solutions Pitch Challenge provided the opportunity for entrepreneurs to showcase their innovative efforts and transformative ideas for sustainable solutions. It is aimed at school learners, with projects being accepted in all fields of science, engineering and music.
