BUILDINGS, CONSTRUCTION SECTOR REQUIRES TWO-PRONGED APPROACH TO DECARBONISE – REPORT South Africa's buildings and construction sector, which includes the operation of residential and commercial buildings, in addition to construction, accounts for about 7% of South Africa's direct emissions. BRICS COUNTRIES EXPAND PARTNERSHIP FOR SUSTAINABLE DEVELOPMENT The BRICS bloc of developing countries, comprising Brazil, the Russian Federation, India, China, and South Africa, decided to expand their alliance to include Argentina, Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates (UAE). In a summit declaration, the BRICS leaders commit to strengthening cooperation to promote peace, a more representative international order, a reinvigorated and reformed multilateral system, sustainable development, and inclusive growth. PLANTING FOOD GARDENS AT ECD CENTRES Old Mutual has partnered with the Nelson Mandela Foundation to establish food gardens at ten Early Childhood Development (ECD) centres in Limpopo, the Eastern Cape, KwaZulu-Natal, and Gauteng. This is part of the Nelson Mandela Foundation's Mandela Day campaign this year, focusing on Climate, Food, and Solidarity. The climate crisis, along with pre-existing challenges of poverty and inequality, places food security at risk for many regions and neighbourhoods. "Through this partnership, we aim to take action against the climate crisis and create food-resilient environments," says Gushwell Brooks, Head of Mandela Day, and Public Outreach, from the Nelson Mandela Foundation. THESE ARE THE PEOPLE WHO LOOK AFTER OUR WATER Charcoal entrepreneurs are helping to restore these grazing areas by removing the wattle, after which it returns to indigenous grass species, increasing the land available for livestock grazing and restoring ecosystem function. Springs in the area that have been dormant for years are reappearing, there is a noticeable recovery of the wetlands and grasslands, and a reduction in soil erosion. 'These are the people who are looking

after South African's strategic water source areas (SWSAs) that provide more than 50% of our entire country's surface water, including a significant proportion of the supply to all our major cities,' says WWF-SA's Water Source Areas Manager, Samir Randera-Rees, who works closely with the WWF Nedbank Green Trust on several projects in SWSAs. **Nedbank**, **25 August 2023.**

PEPSICO BEVERAGES NORTH AMERICA ANNOUNCES FUNDING FOR SALT RIVER PROJECT'S RESILIENT WATER AND FOREST PROJECT IN THE VERDE RIVER WATERSHED PepsiCo Beverages North America (PBNA) announced a commitment of funds to the Salt River Project (SRP) Resilient Water and Forest Restoration Project in the Verde River watershed, one of Arizona's most important waterways. The project focuses on restoring forest structure, composition, and function in a 1,450-acre area of the watershed that supplies water to the Phoenix metropolitan area. Many parts of the watershed are at high risk of wildfire, the occurrence of which would harm SRP's ability to provide resilient water to the Phoenix community. **Pepsico, 24 August 2023.**

CATALYSING TOWNSHIP REVIVAL THROUGH ENTREPRENEURSHIP DEVELOPMENT Community development in a growing country, such as South Africa, entails changes to the social, political, and economic environment. This report was compiled in collaboration with UNICEF in support of Generation Unlimited (GenU) together with the University of Pretoria. Through the PwC/UNICEF collaboration, the University of Pretoria established the Mamelodi Business Hub (MBH), an Entrepreneurship Community Hub. The main goal of the hub is to put community development initiatives into place that support entrepreneurship growth and foster social innovation. PwC, 24 August 2023.

IDC EMPOWERS YOUNG FARMERS THROUGH MARKET ACCESS PROJECT The IDC's corporate social investment arm continuously looks to collaborate with small businesses that aim to empower communities within South Africa. Identifying viable projects and supporting these projects through grant funding, opens doors for the small business entrepreneur, whilst also providing sought after economic upliftment for the communities themselves. Through the Corporate Social Investment division, the IDC recently approved grant funding of R2,000,000 towards Khula App, which provides a digital ecosystem of platforms connecting and enabling role players in the agricultural and food value chain to grow their businesses. REPORT: FINDING PATHWAYS, FINANCING INNOVATION: TACKLING THE BRAZILIAN TRANSITION CHALLENGE Brazil, the fifth largest country in the world and the largest economy in Latin America, plays a critical role in the global fight against climate change. As well as being a key supplier of agricultural, mineral and oil and gas resources, it is also the largest greenhouse gas emitter in Latin America and the Caribbean and home to 60% of the Amazon basin. The paper highlights that in addition to these instruments, the country must also mobilize private funding and develop a national taxonomy. Such developments must inform sectoral decarbonization pathways that establish specific goals and guidelines for each sector, taking into account the nation's unique features.
