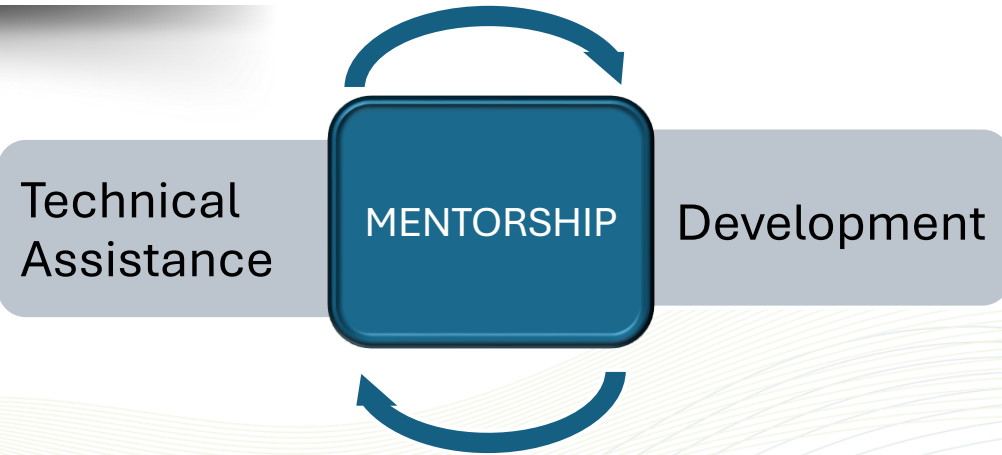

Matjhabeng Local Municipality

Objective

The intervention addresses the **sanitation crisis** in Matjhabeng Local Municipality, initiated as a ministerial directive to mitigate environmental and public health risks.

NBI Activities

Public Awareness Campaigns

Installation of Lockable Manhole Covers to prevent unauthorized access and reduce vandalism.

Capacity Building Mentoring at individual, group, and institutional levels.

Coordination of Water Services Steering Committee.

Regular **Reporting to the Minister and Director-General (DWS).**

Highlights

PMO

Maintenance Planner - improve scheduling, budgeting, and resource allocation

Partial Wastewater Treatment - to reduce environmental pollution.

Asset Transfer Methodology developed - to facilitate sustainable handover of intervention assets to the municipality.

Scope of intervention:

Renovation of 9 Wastewater Treatment Works and 42 pump stations, 380 km of bulk pipelines in 1500 km network

Initial cost estimate of project: R2.5 bil.

Recent cost estimate for completion in 2028/29: R3.4 bil.

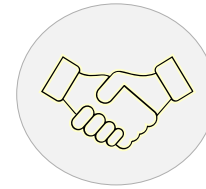

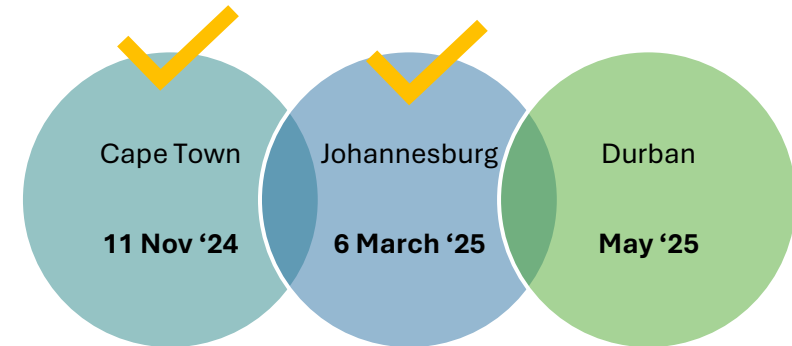
