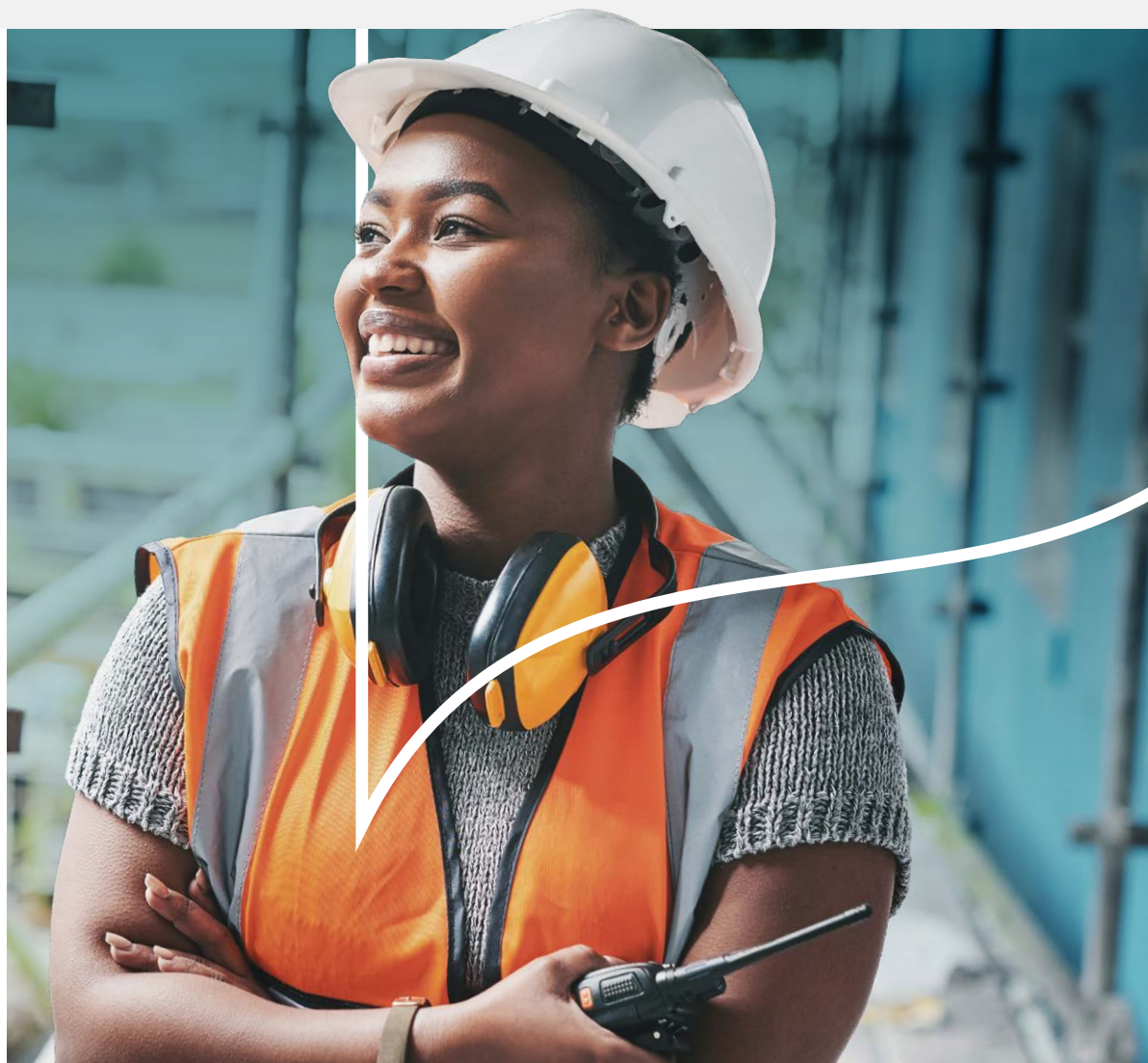


# IRM Hubs:

## Strengthening TVET colleges' role in local economic development

As part of its broader economic inclusion work aimed at improving youth employability, supporting entrepreneurship, and strengthening participation in local economies, the National Business Initiative (NBI) is implementing the Installation, Repair and Maintenance (IRM) Initiative.

Through the Initiative, the NBI is driving the establishment of IRM Skills and Enterprise Development Hubs within public TVET colleges to strengthen the role of colleges in driving localised economic growth and industry-responsive skills development. The Hubs provide integrated training, enterprise acceleration, and enterprise incubation support services to meet the needs of IRM enterprises, unemployed youth and TVET college learners/graduates.

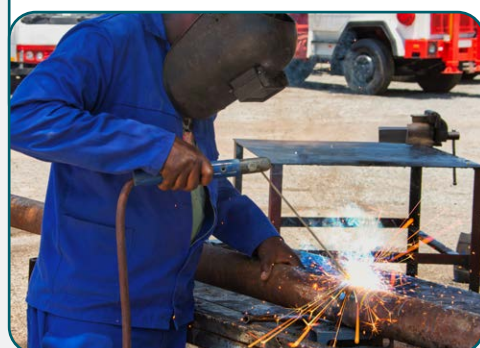

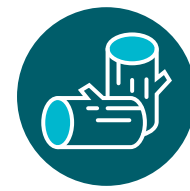
More than a building, each hub creates an integrated ecosystem for the students, workers, unemployed youth and entrepreneurs to **work, build, grow, and connect**.

## IRM Hub design criteria

### Economic Inclusion

The hubs are designed to maximise participation by local MSMEs and local labour, with specific targets to ensure the participation of youth and women during construction.

The architecture is aspirational, seeking to deliver innovative, humancentric and sustainable facilities:



#### Timber-based construction

Where possible, the building is primarily designed as a timber-framed structure, promoting sustainability.



#### Teaching building

Structural elements, connections, pipework and services are intentionally exposed, allowing the building itself to serve as a practical learning and training tool for users and visitors.



#### Use of prefabricated modular components

Where possible, the design incorporates Prefabricated Modular Components (PMCs) to improve quality and sustainability.



#### Reduced environmental impact

The design approach contributes to lower energy costs, reduced carbon emissions and healthier, more comfortable indoor environments.

**EDGE Certification Target: Level 2** certification across all hubs, with a minimum of **20%** reduction in **energy consumption, water use and embodied energy** compared to local baselines. For the Khayelitsha hub, we are aiming for an **additional 20%** reduction, bringing the total target to at least a **40%** reduction in on-site energy consumption compared to the local baseline.
